In accordance with the Government Letter No. ಇಡಿ 36 ರಾಯಸೇ 2014, the NCC Directorate (State Cell), in their letter No. ಎಸ್.1.ಎನ್.ಸಿ.ಇ./140/ನೇಮಕಾತಿ 14-15 dated 25-10-2016, 08-11-2016, 16-11-2016, 05-12-2016 has requested KEA to invite applications online for direct recruitment of LASCAR (Group-D) posts, as per the provisions laid down in Karnataka Directorate of National Cadet Corps (Cadre and Recruitment) Rules 2003. Accordingly applications are invited online from the eligible Hyderabad-Karnataka region candidates who have passed SSLC / 10th Std. / Equivalent examination along with Kannada as one of the languages for direct recruitment of LASCAR (Group-D) for Hyderabad – Karnataka posts (Local Cadre). Recruitment will be done based on the marks obtained in the Qualifying Examination i.e., SSLC / 10th Std. / Equivalent examination. (No Competitive Examination.)

Common Instructions for both the notifications

1. **Age Limit:** As on the last date fixed for receipt of application, the candidate must have attained the age of 18 years and but not have attained the age of,-

Provided that the maximum age limit prescribed above shall be enhanced to Ex-serviceman, In-service, NCC Instructor, Village Group Inspector, Bonded Labourer, Census, Widow and Physically Disabled candidates as per sub-rule (3) of rule 6 of the Karnataka Civil Services (General Recruitment) Rules, 1977.

2. **Qualification:**

- (i) Candidate should have passed SSLC / 10th / Equivalent examination along with Kannada as one of the language; and
- (ii) Must be willing to serve as a member of Home-Guards under the Karnataka Home Guards Act 1962

Eligibility to Physically Disabled candidates: As per Government Notification No. WCD/348/PH8/2015 dated 17-10-2016, only candidates with Low Vision and Hearing Impairment disability are eligible to apply for these posts which are notified through this notification. The candidates with other disability are not eligible to apply.

3. **Method of Applying:**

Candidates have to apply only through online by browsing the URL: “**Recruitment of Group-D**” for the posts notified in Notification -1 above, and by browsing the URL: “**Recruitment of Group-D-HK**” for the posts notified in Notification – 2 above in the KEA Website <http://kea.kar.nic.in> There is no pen and paper method of applying. NOTE: 1. If the candidates desire to apply for the posts mentioned in the Notification – 1 and Notification - 2, then they have to apply separately for each notification, and 2. they **have to pay the fees separately for each post.**

The candidates who are applying for both the posts mentioned in the Notification – 1 and Notification - 2, they have to apply separately for each notification, and they **have to pay the fees separately for each post.**

Note:

- All the relevant certificates / marks cards / formats / reservation claim certificates and such other documents / formats should be obtained on or before the last date fixed for receipt of application specified in the notification.
- The Karnataka Civil Services (Classification, Control and Appeal) Rules 1957, the Karnataka Civil Services (Conduct) Rules, 1966 and the Karnataka Civil Services (Probation) rules 1977 and all other rules for the time being in force regulating the conditions of the service of Government servants made or deemed to have been made under the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) and DPAR 19 SCR 2006 dated 14-08-2006 – Karnataka Civil Services (Direct Recruitment by Competitive Examinations and Selection)(General) Rules, 2006 in so far as such rules are not inconsistent with the provisions of these rules shall be applicable to the selection made and to the persons appointed under these rules.
